Tuesday October 13, 2020**

At the hour of 10:00 a.m., the Board of Commissioners of McCone County, Montana, met in regular session with Alan Stempel, James Moos and Ty Taylor present. Presiding Officer Alan Stempel called the meeting to order. The pledge of allegiance was recited. The agenda was amended to add the CDBG Grant Match Commitment Support Letter.

The October 5, 2020 minutes were approved as read.

Commissioner Moos reported on the Dry Redwater Rural Water Authority Board Meeting he attended in Circle on October 9, 2020.

Allen Rosaaen, South Road Foreman, met with the Board to discuss gravel pits, road repairs and mowing.

The Board met with Tory Matejovsky, GNDC, to discuss the CDBG Grant Match Commitment Support Letter. Commissioner Moos moved to approve the CDBG Grant Match Commitment Support Letter. Commissioner Taylor seconded the motion and the motion passed 3-0. **(A copy of the letter is on file in the Commissioners' files.)**

Tim Sorley, North Road Foreman, met with the Board to discuss road repair issues and a potential equipment purchase to replace obsolete equipment. The Board discussed the Redwater slab. Commissioner Taylor motioned to approve the purchase of approximately \$1,500 of concrete to repair the Redwater slab. Commissioner Moos seconded the motion. The motion passed 3-0.

Paul Skyberg, Deputy Sheriff, met with the Board to discuss Law Enforcement issues.

The meeting was opened to public participation at 1:00 p.m.

Mary Pawlowski met with the Board to present donations for a memorial in honor of Wendell Pawlowski at the McCone County Museum.

Tandi Kassner, Extension Secretary, met with the Board to discuss fairgrounds issues.

Nita Crockett, Treasurer, presented the Cash Reconciliation and Investment Report for September 2020. Commissioner Moos made a motion to approve the report and Commissioner Taylor seconded. The motion passed 3-0. **(A copy of the report is on file in the Commissioners' files.)**

Nancy Stempel, GIS Coordinator met with the Board to provide a GIS update. Commissioner Stempel abstained from the discussion.

Correspondence occupied the Board the remainder of the day.
