Monday November 2, 2020

At the hour of 10:00 a.m., the Board of Commissioners of McCone County, Montana, met in regular session with Alan Stempel, James Moos and Ty Taylor present. Presiding Officer Alan Stempel called the meeting to order. The pledge of allegiance was recited. The agenda was approved.

The October 26, 2020 minutes were approved as read.

Jan Wolff, Retired Commissioner, met with the Board to provide an update on the Action for Eastern Montana Board.

Commissioner Moos reported on the Great Northern Development Board Meeting he attended, by phone, on October 29, 2020.

Tim Sorley, North Road Foreman, met with the Board, by phone, to discuss snow removal preparation and an equipment purchase. The Board reviewed a bid to purchase a Land Pride Mower, 14 foot rotary cutter. Commissioner Moos motioned to approve the purchase of the Mower for approximately \$20,000. Commissioner Taylor seconded the motion and the motion passed 3-0. **(A copy of the bid is on file in the Commissioners' files.)**

The Board reviewed and approved the payroll for the month of October, 2020. Voucher #4 for warrants #83073 through #83084 was issued in the amount of \$20,516.62. Voucher #1013 for automatic deposits in the amount of \$78,630.91 for a total payroll of \$99,147.53 was reviewed and approved. **(Copies of the voucher and payroll register are on file in the Commissioners' files.)**

Payroll Deduction Voucher #1014 for warrants #83085 through #83088 in the amount of \$31,818.43 was reviewed and approved. **(A copy of the voucher is on file in the Commissioners' files.)**

The Board reviewed and approved timesheets for October, 2020 for the employees and department heads under the supervision of the County Commissioners.

The officers' reports for October, 2020 were reviewed and approved for the Sheriff, Clerk of Court, Justice Court, and Clerk and Recorder. **(Copies of the reports are on file in the Commissioners' files.)**

The meeting was opened to public participation at 1:00 p.m.

Sherry Kluth, Election Administrator, met with the Board to discuss the General Election.

Nancy Stempel, GIS Coordinator, met with the Board to discuss GIS issues. Commissioner Stempel abstained from the conversation.

Cal Hogan, VFW Color Guard Commander, met with the Board, by phone, to discuss maintenance at the cemetery.

Jerry Schillinger met with the Board to discuss county issues.

Correspondence occupied the Board the remainder of the day.
